

**FACTS****WHAT DOES TC AUTOMOTIVE PARTNERS FUNDING GROUP, LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Payment history and purchase history
- Credit history and assets

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Automotive Partners Funding chooses to share; and whether you can limit this sharing.

<b>How does TC Automotive Partners Funding Group, LLC protect my personal information?</b>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We limit access to your personal information to appropriate personnel with a business need for it.</p> <p>We provide training and communication programs to educate our personnel.</p>
<b>How does TC Automotive Partners Funding Group, LLC collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ Give us your income information or provide employment information</li> <li>▪ Give us your contact information or use your credit or debit card</li> <li>▪ Apply for financing</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices apply to everyone on your account.
<b>Definitions</b>	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include the following nonfinancial companies: Jim Click Ford Lincoln Mercury, Inc., Holmes Tuttle Ford, Inc., Jim Click Ford, Inc., Jim Click, Inc., Tuttle-Click Ford, Inc., Tuttle-Click's Capistrano Ford, Inc., Tuttle-Click's Tustin Chrysler Jeep Dodge, Tuttle-Click, Inc.</i></li> </ul>
<b>Non-affiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>TC Automotive Partners Funding Group, LLC does not share with non-affiliates so they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>TC Automotive Partners Funding Group, LLC does not jointly market.</i></li> </ul>
